Endeavored best to implement below compliance essentials to ensure hygiene and healthy work environment of the workers, employees as well as rank the company as a perfect compliance factory.

- 3 Sets of 6 feet wide stairs at entrance and exit point of the floor.
- Child day care room consists of adequateinstruments for female worker.
- 28 unitstoilet in proportion to number ofworkers.
- Separate dining room with dining furniture for launch and Tiffin for 30% of the work force.
- Canteen for having light Tiffin with all canteen amenities and fixtures.
- Individual medical help care with full timedoctor and nurse attendance.
- Adequate number of industrial exhaustfan for cooling and ventilation of the floor.
- Adequate number of ceiling fan for daytime cooling at floor.
- Full times Standby power backed by 275kva generator installed at isolated noise free power room.
- Decorative and durable floor tiles at entire factory premises to load and upload ofthe cargos.
- Approved number of fire fightingequipments like extinguisher, firealarm, hose pipe etc is available in accordance with direction given bylicensing authority.
- Workers well fare terms exists in worker recruitment police and are complied religiously.
- Worker salaries are set in compliance with prevailing market pay role that complies with prevailing government guideline.
- Work time counts 6 days in a week and 8 hours followed by 2 hours overtime (ifnecessary each work day.
- Workers and officers check in and out times are recorded by time attendance and access control system backed by HR & pay roll software.



Accreditation

The facility has received a certification based on compliance with the 12 WRAP Principles. The WRAP Principles are based on generally accepted international workplace standards, local laws and workplace regulations which encompass human resources management, health and safety, environmental practices, and legal compliance including import/export and customs compliance and security standards.

WRAP enjoys wide support from the global apparel industry but is, at the same time, independent of the industry. Active support is provided by the International Apparel Federation and more than 20 additional trade and industry associations from around the world.

"BSCI" affirmed consistency and harmonization for "Vertex" to improve their social compliance in the global supply chain. "BSCI" aims to establish a common platform for the various European companies Codes of Conducts and monitoring systems, it also lays the groundwork for a common monitoring system for social compliance. The competent authority stringently apprised "Vertex" experience and know how ability in conformity with BSCI pillar principles and eventually affirmed its credibility to get certified.

The Accord is an independent agreement designed to make all garment factories in Bangladesh safe workplaces. It includes independent safety inspections at factories and public reporting of the results of these inspections. Accord incepted their responsibilities as to surveying on fire and building safety in Bangladesh. A part of it here safety issues are identified, retailers commit to ensuring that repairs are carried out, that sufficient funds are made available to do so, and that workers at these factories continue to be paid a salary. "Vertex" facility experienced an elaborate and stringent inspection carried out by Accord's delegates to asses factory building and fire safety status which endorsed the factory is compatible to operate under the codes of Accord safety.

Oeko-Tex® is the world's leading certification for textiles, leather and accessories that have been tested for harmful substances. Around 10,000 producers in nearly 90 countries along the entire textile chain participate in the Oeko-Tex® certification system, which is the best known and most widespread brand in the world for textiles tested for harmful substances. A product may only be Oeko-Tex® labeled or certified if all the components meet the requirements for the appropriate product category. When a product is Oeko-Tex® marketed or labeled, a certificate number must always be shown, as well as the institute that issued the certificate.

The Global Organic Textile Standard (GOTS) was developed through collaboration by leading standard setters with the aim of defining requirements that are recognized world-wide and that ensure the organic status of textiles from harvesting of the raw materials through environmentally and socially responsible manufacturing all the way to labeling in order to provide credible assurance to the consumer.

GOTS is introduced in 2006 which has gained universal recognition, enabling processors and manufacturers to supply their organic textiles with one certification accepted in all major markets.
